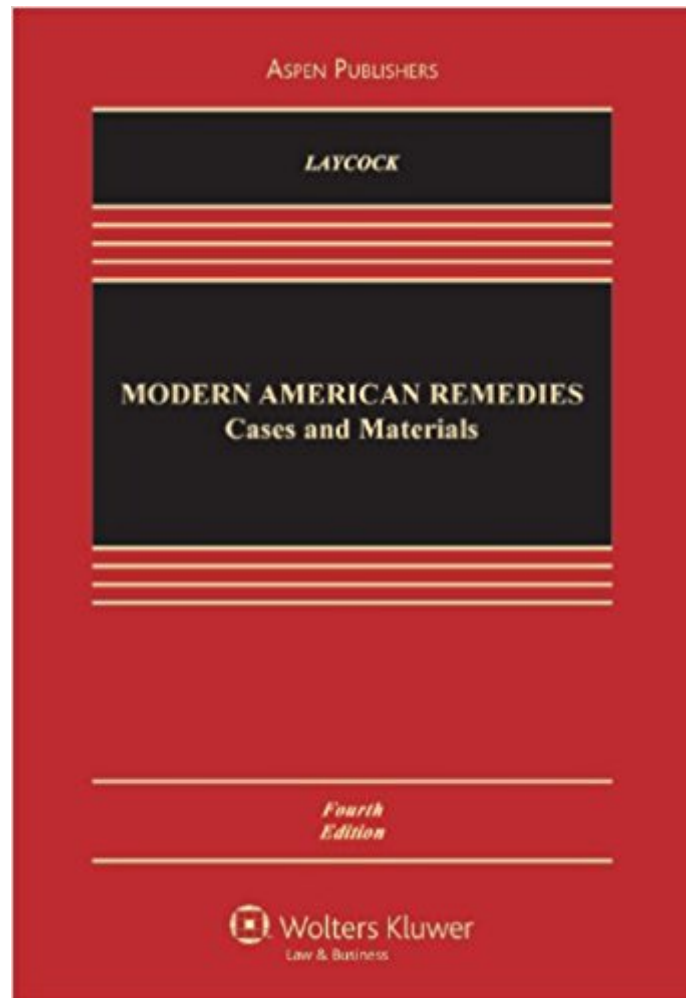

There is a LOT of highlighting, underlining, and notes in the book. Definitely very distracting.
